 - c. Deceased Estate—all executors to sign and an original certified copy of Probate or Letters of Administration must be forwarded with this form. If not already provided for Joint trustees and company accounts, an original Certified copy of the Death Certificate is required.

How to Complete the Form

1. Seller's HIN – it can be found on the CHESSE holding statement or you can contact the respective Macquarie broker for assistance
2. Seller Account Number – complete with the Broker's Participant Identification Number of your Macquarie Trading account. If unknown, enter the Broker's name
3. Full Name(s) of Seller(s)/Transferor(s) – Name/s in which the shares are currently registered including designation if applicable
4. Full CHESSE Address of Seller(s) – Address of Seller(s) where holdings are currently registered. This may be obtained from the holding statement
5. Buyer's HIN – it can be found on the CHESSE holding statement or by accessing the Macquarie Online Trading platform
6. MOT Account number – this is the client account number of the Macquarie Online Trading account
7. Full Name(s) of Buyer(s)/Transferee(s) – Name/s of which the shares will be registered including designation if applicable
8. Full CHESSE Address of Buyer(s) – Address of the Buyer(s). If the holding is to be amalgamated, the exact address on the latest statement must be entered
9. Buyer(s)/Transferee(s) Signature(s) – same requirements as point 5
10. ASX Code – individual abbreviated code that uniquely identifies the company or corporation in which the securities are held (e.g. Bell Financial Group–Code BFG).
11. Security Name – the full name of the company or corporation in which the securities are held (e.g. Bell Financial Group).
12. Quantity – written in both words and figures, the number of securities being transferred
