#### General terms which apply to all levels of authority

6.1 You:

- a) indemnify us against all loss, liabilities and costs incurred directly or indirectly as a result of the appointment of a third party
- b) indemnify us against all loss, liabilities and costs incurred directly or indirectly in connection with any action by a third party under their appointment or any payment made from your account on their instruction

## Terms and conditions (continued)

- c) release us from all claims and liabilities in connection with any act or omission relating to the appointment of a third party to your Account, and
- d) release us from all claims and liabilities in connection with any action by a third party under their appointment or any payment made from your account on their instruction.
- 6.2 However, we remain liable for any loss or liability which, by operation of law we cannot exclude.
- 6.3 This authority takes effect on the date that we amend our records to note the appointment and continues until you cancel it by telling us in writing. Cancellation also takes effect on the date that we amend our records to note the change.
- 6.4 We may cancel the appointment of a third party as an authority on your account by telling you in writing.
- 6.5 In the event of the death of an account holder, the authority given under this form will automatically terminate.
- 6.6 Third parties may not set up Direct Debits on your Account or give other third parties access or authority on your Account.
- 6.7 You agree to terms and conditions for Macquarie Online as set out in the applicable offer document available from macquarie.com.au/personal.

#### Cash Management Account Enquiry Authority

- 6.8 You:
  - a) authorise the third party to have access to information about your account
  - b) You do not authorise the third party to make withdrawals from your account, make any changes to your account details, close your account or enable use of your cheque book.

#### **Online Trading Full Trading Authority**

- 6.9 You:
  - a) authorise the Authorised Party/Parties outlined in this document to act on your behalf in connection with all products and services, to the extent of their authority set out below:
    - i. To have access to, enquire about and receive information pertaining to your account.
    - ii. To acquire, buy, deal with, dispose of, or sell any financial products.
  - b) acknowledge that you are responsible for and bound by the instructions given by the Authorised Party/Parties, and you indemnify Third Party Platform Pty Ltd in relation to the actions of your Authorised agent.
  - c) acknowledge that the Authorised Party/Parties will be provided relevant account access and you will not provide your personal access and login details to the Authorised Party/Parties.
  - d) acknowledge that it is your obligation to be aware of any activity undertaken on my/our behalf by the Authorised Party/Parties.
  - e) authorise and request Macquarie Online Trading to accept and act upon any instructions issued by the Authorised Party/Parties pursuant to this authority and undertake to ratify whatever the signatory lawfully does or causes to be done pursuant to this authority.
  - f) understand that the appointment of an Authorised Party/Parties remains effective until revoked by providing notice in writing.

6.10 You:
