This amount relates to the proportion of each person's role, as it relates to their involvement with MIML, in its capacity as the Trustee of the MSP. - **Political donations** – The Trustee does not make political donations.
- **Promotion, marketing or sponsorship expenditure** includes design, production and distribution of fund promotional or educational materials, advertising development and media costs, sponsorships and partnership arrangements. This expenditure is necessary to grow the Fund.
- **Industrial body payments** – The Trustee doesn't make payments to industrial bodies as defined under the *Fair Work (Registered Organisations) Act 2009*.
- **Related party payments** occur when payments are made to related entities of the Trustee for services and goods provided to the Fund.
