#### WiseTech Global Ltd (WTC)

We have been advised that Phi Finneu McDonald (PFM) is seeking compensation on behalf of shareholders who suffered losses after acquiring WiseTech Global Ltd (WTC).

The proposed class action alleges that WTC breached its continuous disclosure obligations and/or engaged in misleading and deceptive conduct by providing its FY20 guidance on 21 August 2019, and reaffirming that guidance in October and November 2019, without reasonable grounds.

- The proposed class action is on behalf of investors who acquired IAG shares between 21 August 2019 to 18 February 2020 (inclusive) (claim period).

- In no circumstances will group members be out of pocket by participating in the group proceeding – whether the case is successful or unsuccessful.

## Foreign Tax (including W8BENs)

#### W8BENs

Investors who are not US citizens or US residents for tax purposes and hold dual listed securities listed in the US, are required to complete a Declaration of Foreign Residency (or 'W-8BEN form'). Equivalent forms may also be needed and provided for securities listed or dually listed in other nations, such as Canada and Ireland.

Each security now requires that your clients complete a separate W-8BEN form per beneficial owner. Entities are still required to complete the W-8BEN-E form.
